EMERGENCY MEDICAL ASSISTANCE PLAN FOR: LIMONEXTREME SKY RACE

Presentation

This document, prepared by Power Emergency S.R.L., in collaboration with A.S.D. S.S. Limonese – Via Capitelli, 11 – 25010 Limone sul Garda (BS), intends to provide a tool for the coordination of medical resources used in the aforementioned event, which will take place on the days October 28, 2023 from 9:30 pm to 18:00 pm

Description of the Plan

The plan is composed of six parts:

- A first part that describes the classification of the Health Service, the resources (human and vehicles) made available by the Health Service, including the telephone numbers and names of the personnel involved;
- A second part, which indicates the type of service, specifying key roles, the communication system and hierarchy, communications within the health service and from the health service to the public, as well as to the other components of the safety service;
- A third part that includes all procedures;
- A fourth part that deals with handling any major accidents;
- A fifth part that includes the maps regarding the deployment of resources;
- A sixth and last part regarding COVID-19 prevention and hygiene information.

PART ONE - Classification of the Health Service and resources (humans and vehicles)

Classification

Based on the number of participants declared by the organization of the event (approx. 1,000 persons), the laws in force, as well as the various guidelines issued for managing medical assistance and rescue activities to guarantee events of the same type, the following medical assistance system has been activated:

Personnel: (we certify that all staff have the requisites necessary for providing medical assistance)

- N.1 – D.S.S. Health Service Director
- N.1 – C.S.S. Health Service Coordinator
- N.1 – D.T. Transport Manager
- N.1 – S.S. Sector Supervisor
- N.1 - Doctor
- N.3 – Nurses
- N.6 – EMTs / Drivers (present on the 2 emergency vehicles - Ambulance cat. A - qualified for emergency assistance and transportation outside of the hospital)
- N.4 – Rescuers/Staff from Tignale Soccorso (divided into two teams on foot)
- N. 45 – Volunteers on foot (deployed along the route) who are part of the various groups involved

Equipment and Facilities:

- N. 2 – Ambulances Cat. "A" qualified for emergency assistance and transportation outside of the hospital
- N. 1 - Motorcycle Rescue with Nurse (street bike) - A.L.S. Advanced Life Support + D.A.E. devices
- N. 3 – A.L.S. – Advanced Life Support devices, complete with adult / pediatric sets and defibrillator
- N. 2 – B.L.S. - Basic Life Support devices
- N. 6 – Defibrillators

Arrival of vehicles, personnel and working hours

In consideration of the type of event and the large number of visitors, a chronological activation of the following resources has been planned as described:

- ✓ Medical Staff
- ✓ Volunteer Staff

PART TWO - Medical Staff Organization - Key roles, communication system, hierarchy, medical facilities

Health Service Director - D.S.S.

The position is held by Dr. Antonio Cerrone – Doctor

The D.S.S. has the task of verifying and ascertaining the correct functioning of health services during the event.

To coordinate all resources, the collaboration of C.S.S. is used.

Health Service Coordinator - C.S.S.

The position is held by Luca Fanti – Nurse

The C.S.S. has the task of coordinating health services during the event. For these activities, he makes use of all the health personnel employed (doctors, nurses and rescuers of every qualification).

During the event the C.S.S. will be present at the I/F Race point located on Via Lungolago Marconi – Limone sul Garda (BS) from which he will coordinate the entire service in close collaboration with the D.S.S., and the other components present on site.

These are C.S.S. tasks:

- ✓ Coordinate by radio/telephone all emergency calls
- ✓ Record emergency calls and timing
- ✓ Collect and compile the service report and the record of the emergency call.

Transport Manager - D.T.

The position is held by Luca Fanti – Nurse

These are D.T. tasks:

- ✓ Deploy teams as set forth in this document
- ✓ Handle available vehicles

Sector Supervisor - S.S.

The position is held by Raffaele Caracciolo - EMT

These are the tasks of S.S.:

- ✓ Prepare all materials for your team in the assigned area
- ✓ Receive the staff in your sector and divide them into teams as planned
- ✓ Identify a leader for each team
- ✓ Hand over the radio equipment and check that it is working properly
- ✓ Hand over the supplies provided
- ✓ Check the correct positioning of the team in the area as planned
- ✓ Instruct the team on how to intervene
- ✓ Intervene on request of the C.S.S. to support the teams in his sector
- ✓ Collect all distributed material/supplies
- ✓ For any need, the S.S. must refer to the C.S.S.

Nursing Staff

These are the nurses' tasks:

- ✓ Take charge of the devices in your possession, ensuring their correct use and functioning. In the event of anomalies, the nurse must promptly inform the C.S.S.
- ✓ Provide assistance and perform your job, if needed
- ✓ Compile reports regarding medical treatments done; compile the A.R.E.U. – Azienda Regionale Emergenza Urgenza medical chart in the case of hospitalization if, on the instructions of the Operations Room, the nurse must accompany the patient to the D.E.A. – Emergency Room Admissions.

During their service, nurses refer to the C.S.S.



Team Leaders and Sector Supervisors

The tasks of the team leaders and sector supervisors are:

- ✓ Coordinate and manage the team, both on a technical and medical assistance level

During their service, they refer to the C.S.S.

Rescue Staff

The tasks of the rescuers:

- ✓ Perform your job according to your skills and abilities, following the instructions of the team leader and, if present during the emergency, following the instructions of the nurse or doctor regarding medical assistance.

COMMUNICATION SYSTEM

The medical system uses the following connections

- ✓ Mobile phone;
- ✓ Radio System (internal / local communication system).

SECURITY COORDINATION

The coordination of the system in question is the responsibility of the G.D.F. – Finance Police group at Centro Sportivo Comunale – c/o Campo Sportivo – Limone sul Garda (BS) Fedrici Giovanni (mobile 3393671507)

MEDICAL EQUIPMENT AND STATIONS

- ✓ Ambulances Tignale Soccorso – Limone sul Garda (BS): M.S.B. + D.A.E.
- ✓ P.M.A. – Advanced Medical Station – restricted space adjacent to the events area for patient assessment.



PART THREE - Operative Procedures

With regards to the coordination and management of on-site assistance, all patients must transit through the place for patient assessment so that an in-depth evaluation of the same is carried out c/o the P.M.A. – Advanced Medical Station. Once the patient’s medical conditions have been assessed, if there is a need for hospitalization, medical staff will interface with the Operations Room of reference that will be S.O.R.E.U. Alpina – Bergamo (BG).

PART FOUR - Major Accident Management

In the event of a major accident, meaning an event that requires the use of extraordinary resources and procedures, the D.S.S., together with the C.S.S., after guaranteeing the safety of all personnel, will inform the Operations Center of reference, for territorial jurisdiction, that a major accident has occurred.

Subsequently, the D.S.S. will follow the instructions given by the Operations Center of reference.


The maps for the routes taken by the participants are attached in the G.A.M.E.S. portal of AREU Lombardia.
